




Food Code Adoption Status Annual Report




Food Code Adoption Status in 2022



•34 States have adopted one of the three most recent versions (2022, 2017, and 2013 version). representing **62.47** % of the U.S. population. •18 States have adopted one of the two most recent versions (2022, and 2017 version), representing 43.42 % of the U.S. population. •2 States and 2 Territories have adopted the most recent version (2022 version). representing 4.82% of the U.S. population.

State Regulatory Agencies Have Responsibility for Oversight of Restaurants, and/or Retail Food Stores





National FDA Food Code Adoption Strategy

All jurisdictions that regulate retail food establishments adopt the most current, science-based regulations and standards such as those found in the FDA *Food Code* including its Annexes and the Supplement.



Food Code Adoption Status from 2016 to 2022



Key findings:

- •Adoption of the 2017 Food Code increased every year since it was published in February of 2018 and before the 2022 Food Code was published.
- •Adoption of the 2013 Food Code was increased before the 2017 Food Code was published and decreased after the 2017 Food Code was published.
- •Adoption of the 2009 Food Code decreased from 22 States to 9 States between 2016-2022.
